

city of North Battleford Saskatchewan BYLAW NO. 2134

A BYLAW OF THE CITY OF NORTH BATTLEFORD, IN THE PROVINCE OF SASKATCHEWAN, TO AMEND BYLAW NO 1706, BEING THE WATERWORKS SYSTEMS BYLAW.

WHEREAS pursuant to Section 8 of *The Cities Act 2002*, Council may pass any bylaws in relation to public utilities including the establishing fees for providing those services;

WHEREAS pursuant to Section 17 of *The Cities Act 2002*, Council may provide a public utility service,

WHEREAS the Council of the City of North Battleford deems it necessary to amend The Waterworks System Bylaw No. 1706;

NOW, THEREFORE, the Council of the City of North Battleford in the Province of Saskatchewan, enacts as follows:

 That Schedule "B" be deleted in its entirety and replaced with the following Schedule "B":
