All references in the RFQ to July 8 or 22, 2026 as the Submission Deadline, Closing Time, SOQ closing date, or Closing Date and Time are amended accordingly to August 5, 2026 at 2:30 p.m., Saskatchewan Time.

2.0 Question and Answer

Question 12: We would like to request a two-week extension to the RFQ submission date.?

Answer 12: Yes. The City will grant a two-week extension to the RFQ Submission Deadline. The revised Submission Deadline / Closing Time is August 5, 2026 at 2:30 p.m., Saskatchewan Time.
