## **Frequently Asked Questions**

**What happens at the council meeting?** At the council meeting the application will be presented to Council. Council may ask the applicants questions regarding the application. If you have submitted a letter or an email regarding the application, it will be provided as public information.

**Has the application been approved?** The application has not been approved. The application for the discretionary use is being brought forward to council for consideration. At the January 24th, 2022 council meeting, council can approve the application, deny the application, or ask for more information.

**Is this a City of North Battleford project?** This is not a City of North Battleford project. Administration has received an application from a group wanting to establish a Homeless Shelter – Multiple Unit Dwelling. As the use is discretionary, it requires council approval.

**How can I voice my concerns or support?** If you wish to provide comments on the application, you can submit your comments in writing in person at City Hall, through regular mail, or by email ([corporateservices@cityofnb.ca](mailto:corporateservices@cityofnb.ca)).
